Expectations:

Payment in full is expected at the first practice of the season if not paid at the time of registration. Payments can be made via cash, check, or website. Students will arrive in comfortable clothing and shows, with hair pulled back from face. Students should bring their own water bottle. If your child is in the 4–7-year-old class they must be accompanied to practice and then also out of practice, unless the studio has written consent from parents for the child to walk home. All questions and concerns should be taken to your child’s coach. We pride ourselves in being a positive learning environment – disrespect will not be tolerated.

Things to note:

We are a competitive dance and baton studio. If you do not wish to partake in competitions please note this is our primary goal and this may not be the best fit for your child.

Season Outline:

Season starts in September. Halloween parades happen in the month of October. Group competitions run from February to May. There are individual baton competitions from December to May and those are optional. There are intermittent community parades and performance events.
